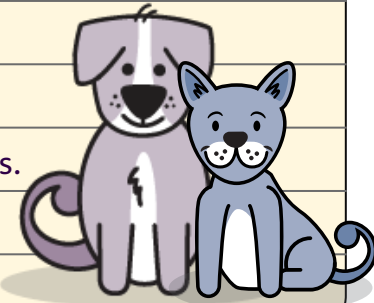

Assessment

Cyclosporine while FDA approved for humans is completely extra label for dogs.

Had owner sign consent form for experimental/not recommended therapy.

CHECKLIST

All medical record examinations should include the SOAP notes:

1 Subjective

What the patient reports - symptoms, complaints, and history in their own words.

2 Objective

Measurable, observable findings - vitals, physical exam results, and test data.

3 Plan

The proposed course of action - treatments, medications, referrals, or next steps.

4 Assessment

The clinician's diagnosis based on the subjective and objective information.

If this information is not present, the document may be insufficient for filing a claim.
Please reach out to your vet for additional documentation.

MEDICAL RECORDS:

✘ Documents that DO NOT count

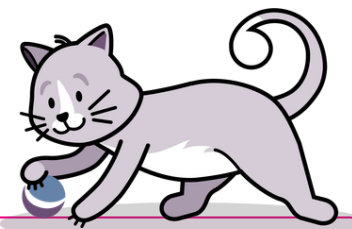
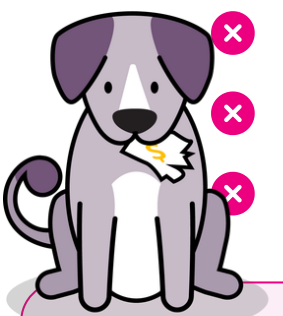
To verify your pet's physical exam or to process your claims, we'll need a copy of all medical records from your veterinarian(s). Having them ready helps us confirm your pet met the enrollment requirements and keeps your policy active so you can maintain Furkin awesome coverage!

✘ What DOES NOT count

These documents are helpful, but they cannot be used to verify a complete physical exam on their own.

- ✘ Vaccine certificates
- ✘ Rabies certificates
- ✘ Pet passports
- ✘ Quarantine records

- ✘ Receipts or invoices
- ✘ Prescription labels
- ✘ Boarding records
- ✘ Grooming records



These documents don't include the necessary veterinarian SOAP notes as detailed on page 1.

✔ Need a copy of your records?
